Extension of timeline for submission of the Expression of Interest for Preparation of Integrated Management Plan along with DPR for "State of Art Wetland Conservation and Ramsar information Center" for the ecological restoration of Ramsar sites and for promoting awareness and low impact responsible ecotourism and livelihood opportunities of the local communities for 3 Ramsar sites i.e. Vellode Bird Sanctuary, Karikili Bird Sanctuary and Vaduvur Bird Sanctuary under the Tamil Nadu Wetlands Mission.

- 1. This refers to the 'Request for Expression of Interest' (EOI) for Preparation of Integrated Management Plan along with DPR for "State of Art Wetland Conservation and Ramsar information Center" for the ecological restoration of Ramsar sites and for promoting awareness and low impact responsible eco-tourism and livelihood opportunities of the local communities for 3 Ramsar sites i.e. Vellode Bird Sanctuary, Karikili Bird Sanctuary and Vaduvur Bird Sanctuary under the Tamil Nadu Wetlands Mission issued on 01.09.2023. The last date for submission of EOI was earlier fixed on 15.09.2023.
- 2. Now, the last date for submission of EOI is extended from September 15, 2023 to September 25, 2023. The interested organizations / institutions may offer their detailed proposal along with the methodology and work plan latest by 5 PM Indian Standard Time on September 25, 2023. The overall cost DPR and concept design should not be above Rs.25,00,000 / inclusive all taxes.
- 3. Other than the extension of time for submission of the EOI proposed, all other terms and conditions of the Invitation for EOI remains unchanged.
