REQUEST FOR EXPRESSION OF INTEREST

As part of the implementation of Tamil Nadu Wetlands Mission. the request for Expression of Interest is invited from the experienced Organization/ Non-Government Organizations / Consultants for taking up the following work.

1. Engaging of State Level Coordinator under the Tamil Nadu Wetlands Mission for two years under Tamil Nadu Wetlands Mission, the Expression of Interest (EOI) is invited for engaging the State Level Coordinator for two years under the Tamil Nadu Wetlands Mission. Details of this Expression of Interest is available in the Web portals www.tnswa.org and www.tnforests.nic.in. The interested Non-Government Organizations / Individuals may offer their proposal within 10 days. Details of the organization, past experiences. registration with legal authorities and other relevant details are invited. The details may be sent to this office on or before 28-06-2023. The proposals will be examined and the outcome will be intimated about the terms and conditions of the work. after the approval of the Government of Tamil Nadu
2. **Scope of Work for the State Level Coordinator:**
 - a) To develop liaisoning with all Government Departments, Non-Government Organizations, corporate bodies, private institutions, public and other multi stake holders up to the panchayat level in the State of Tamil Nadu for effective coordination and implementation of the objectives of the Tamil Nadu Wetlands Mission. (Please refer to the web portal of Tamil Nadu State Wetland Authority at www.tnswa.org)

- b) To select the wetlands in peri urban and rural areas which have disappeared or degraded and having an extent of <2.25 ha and belongs to village panchayat. The wetlands larger in size and not more than 5ha may also be selected.
- c) To create awareness camps among school students and local communities on the importance of wetlands for the publicity and awareness among the public and stakeholders up to the village panchayat level.
- d) To mobilize communities for community-based wetlands restoration under the guidance of the institutions and experts involved in the wetlands conservation for improving the water quality, fish quality and biodiversity status in the wetlands
- e) To coordinate with the District Level Wetland Management Committees in each district in getting the necessary clearances for the restoration works of the selected wetlands.
- f) To mobilize of CSR funds and public donations for restoration of the selected wetlands.
- g) To document pre restoration and post restoration activities of restored wetlands and uploading of high-resolution photos and videos of the restored wetlands and other related activities of the entire districts on the web portal of Tamil Nadu State Wetland Authority at www.tnswa.org .

3. **Duration of the work:**

The State Level Coordinator nominated shall be engaged for the initial duration of two years only. The said engagement shall be purely performance based and the State Level Coordinator may be replaced in

case of lack of quality performance. The eligible honorarium of about Rs.15,000 / month shall be paid to the State Level Coordinator for the work mentioned under the scope of work. The engagement is purely on temporary basis subject to the decision of the Tamil Nadu Wetlands Mission.


4. Submission of EOI :
